

BUNCOMBE COUNTY PERMITS & INSPECTIONS**PERMIT FEES****(Effective July 1, 2010)**

Building Permits includes fees for all trade permits (Building, Electrical, Mechanical & Plumbing); Building Permit fees shall be collected at the time of the permit application and plan submittal. For commercial plans submitted prior to the permit application reference Section II (b) for applicable review fees.

II. Non-Residential/Commercial Permits and Inspections Fees:

***Non-Residential Construction: Construction cost shall be based on contract cost or “ICC-Building Valuation Data”**

- b) Plan Review Fee (based on construction cost):

- c) Multi-Family Dwelling
Building Shell Cost is based on Section II Non-residential fees PLUS an additional cost of \$350.00 per unit
Electrical, Plumbing and HVAC included: \$25.00/unit more for gas
- d) Modular Office/Classroom \$250.00
- e) Non-Residential Renewal 50% of original permit fee (One Time Only)
- f) Signs \$75.00 per trade plus review fee (Section II-b)
- g) Day Care Centers or ABC License Inspections Requested inspections for Day Care or ABC
License Inspections of a routine nature of work or
Structure not requiring a permit under Article III
of this ordinance shall be charged at a flat rate of
\$75.00 per trade.

- h) EXPEDITE SERVICE FEE (for special processing, and after normal hours service) \$75.00 hour/per staff member, with a minimum of \$150.00 (2hours) for weekends, or time not contiguous with normal work hours

III. Temporary Certificate of Occupancy (TCO) & Temporary Utilities Fees:
 (Fees will be doubled when not renewed prior to expiration date. Utilities to the building will be disconnected within 48 hours of the expiration of the TCO or Temp Utilities).

Commercial Permits:

Temporary Certificate of Occupancy	\$200.00 (for first 30 days)
& Temporary Utilities	\$100.00 (renewal before expiration)

Residential Permits:

Temporary Certificate of Occupancy	\$75.00 (for first 30 days)
& Temporary Utilities	\$50.00 (renewal before expiration)

IV. Refunds for Residential & Commercial Permits:

- A. Minimum charge for processing of permit refunds is a \$75.00 administrative fee
- B. Active Residential Permits with no inspections will be refunded provided all original paperwork is returned to the Permits & Inspections Department, minus a 10% administrative fee or \$75.00 (whichever is greater).
- C. Refunds for active Commercial Permits with no inspections will be charged the plan review fee in addition to the \$75.00 administrative fee.
- D. An additional fee of \$50.00 will also be charged for each inspection that has already occurred on both Residential and Commercial Permits.
- E. No refunds will be issued six months or more after the permit is issued or plans reviewed.
