## Mandatory Certification

*required beginning April 2010*

New EPA training requirements are now in place for Certified Renovators. The new EPA rules apply to contractors who renovate or repair housing, child-care facilities or schools built before 1978. Under the new rules, trained contractors and workers must follow lead-safe work practice standards to reduce potential exposure to dangerous levels of lead during renovation and repair activities.

The requirements apply to anyone who could potentially expose children to lead dust during their work and includes builders, painters, plumbers, and electricians. In April 2010, this certification will become MANDATORY for anyone who could potentially expose children to lead dust.

This course has a 1:10 teacher to student ratio so space is limited – we will accept up to 10 students and increase to a max of 20 if necessary. Please call the AHBA today to reserve your spot!
